# WELCOME TO THE 3RD CLARETS TRUST NEWSLETTER

It has been very busy since our last newsletter. The closing date has passed for applications for the Trust board and as there were fewer candidates than positions available, an election is not required. This means we now have a Trust Board, which will need to be ratified at a special meeting prior to the 'Audience with Steve Cotterill' event on 21st April. With a number of positions available, the board will also seek to coopt additional representatives.

There have also been two open meetings, and both have been well attended with some positive ideas being put forward. The key issue at present appears to be the ground and whether the Trust could and should look at buying it back. We are looking to set up a savings scheme but are aware that before we do anything we must make sure that our members are consulted and allowed to decide that this is the direction the Trust should take.

Planning has also been ongoing for the Beer Festival and the Audience with Steve Cotterill, which both take place later this month. In order to run events such as this we need people to volunteer to help out and also to support the event by turning up. At the beer festival volunteers will be needed for setting up, selling programmes, glasses and beer vouchers and manning the bars over the three sessions as well as taking everything down on the Sunday. It's a lot of work and many hands make light work as they say. I go back to what I said at the first open meeting 'Don't ask what the Trust can do for you. Ask vourself "What can I do for the Trust?"

Those of us on the board are no different to you - supporters and volunteers. The more we can share the work around, the more we can get done and the easier it will be. Every little helps.

# FIRST CLARETS TRUST BEER FESTIVAL

Friday 15th - Saturday 16th April



Foundation Lounge at Turf Moor

The weekend of 15<sup>th</sup> – 16<sup>th</sup> April will see the Foundation Lounge at Turf Moor transformed into a beer enthusiasts' paradise. Over thirty real ales will be available over the weekend from both local and national breweries, but the feature event will be the launch of the Trust's very own ale on Friday night. The event has been organised with help from East Lancs CAMRA, the Burnley Express and, of course, Burnley F.C.

The weekend commences on Friday evening (15th April) and you can sample the many beers on offer between 7pm and 11pm. On Saturday (16th April) the day begins at 11am, and will run right through until 11pm, with the exception of a two hour break between 3pm and 5pm, when action on the pitch against Brighton & Hove Albion will be everyone's primary concern.

As we have already mentioned, the weekend will also see the launch of the Clarets Trust beer. The name is a closely guarded secret but it will be named after a very famous name from Burnley FC's past. The first pint will be pulled by a special guest around 8pm.

Entry to this event is a very reasonable £3.50, although this will reduced to just £3.00 for Trust members on production of your membership card. The entry fee also includes an event programme and glass hire. Tokens for purchasing beer will be available in denominations of £1.

We are still looking for some sponsors for the beers at £50 a barrel. This buys advertising in the programme and on the barrel at the event, free entry to a Friday night preview plus £10 worth of beer vouchers. Anybody interested please get in touch with us, using the contact details overleaf.

The consensus view appeared to be that the Trust should concentrate on attempting to buy back Turf Moor.


